Food Vendors must get a Permit form from the Health Dept of Grays Harbor. Go to co.grays-harbor-wa/, then to County Depts., Choose Temporary Good Permit and print. If you do not have access to a computer call 360 249 4413 to request a permit be mailed to you.

All return applications **must be accompanied by a check or money order for the full payment due**, made payable to RSPD 2011. This fee is non-refundable once notice of acceptance is mailed. All applicants must send a completed application and Hold Harmless Agreement (below) signed and dated. All New applicants must send 2 photos of items to be sold and of the booth display. All applicants must have a **WA state Business License (UBI#)**. Also, please enclose a self addressed and stamped envelope. Ineligible applicants fees will be returned promptly. You will be informed of your space when you arrive on June 23rd or 24th. Assignment of booth space and location is at the discretion of the RSPD Committee. **RSPD 2011 reserves the right to refuse participation to any applicant with displays or items deemed unprofessional in any manner.**
